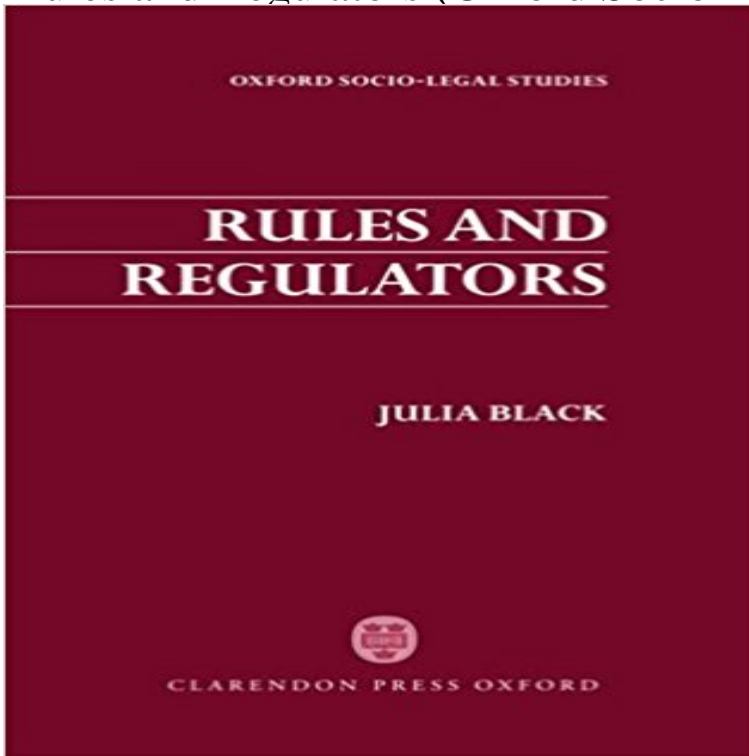


Rules and Regulators (Oxford Socio-Legal Studies)
