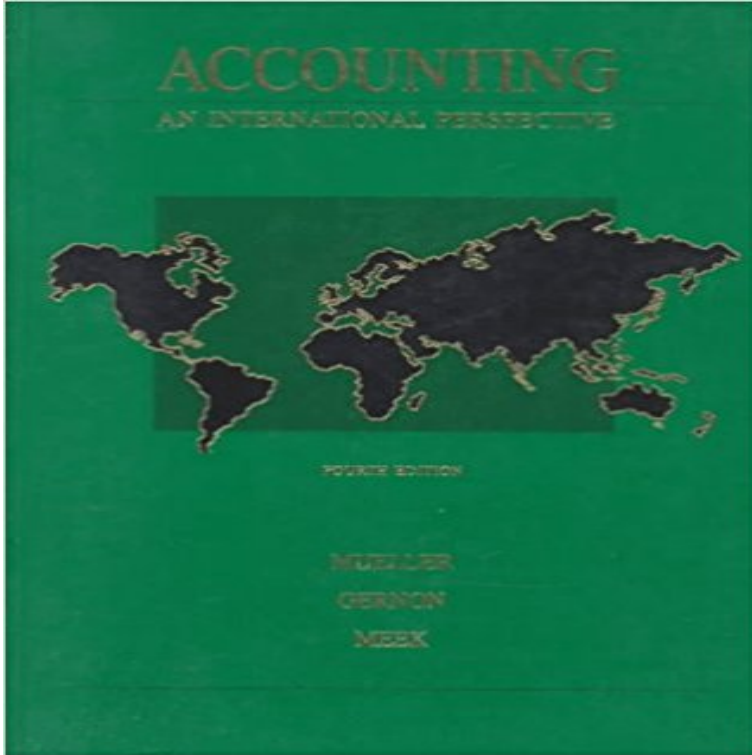


# Accounting: An International Perspective (Irwin Series in Undergraduate Accounting)
