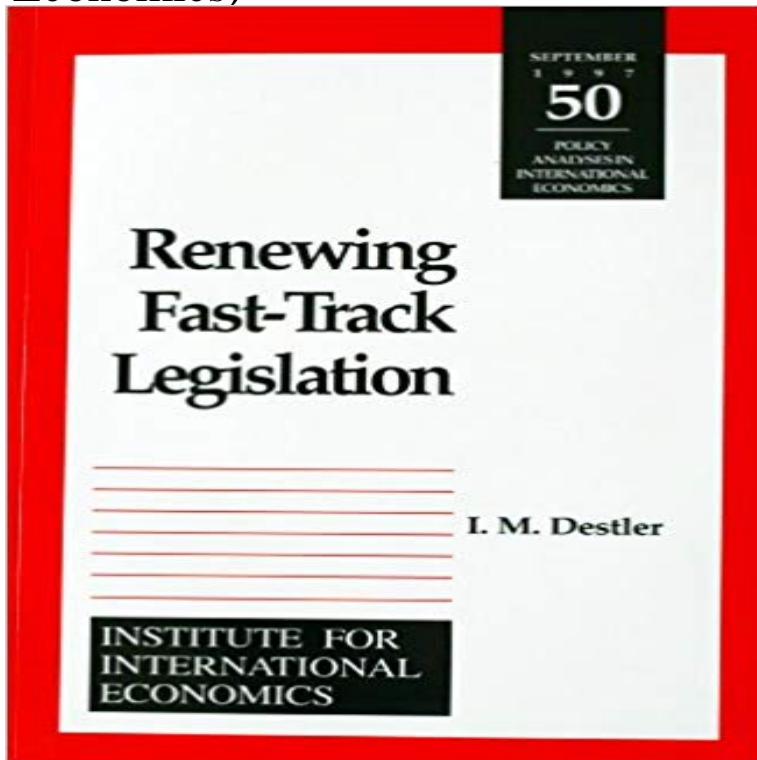


Renewing Fast-Track Legislation (Policy Analyses in International Economics)
