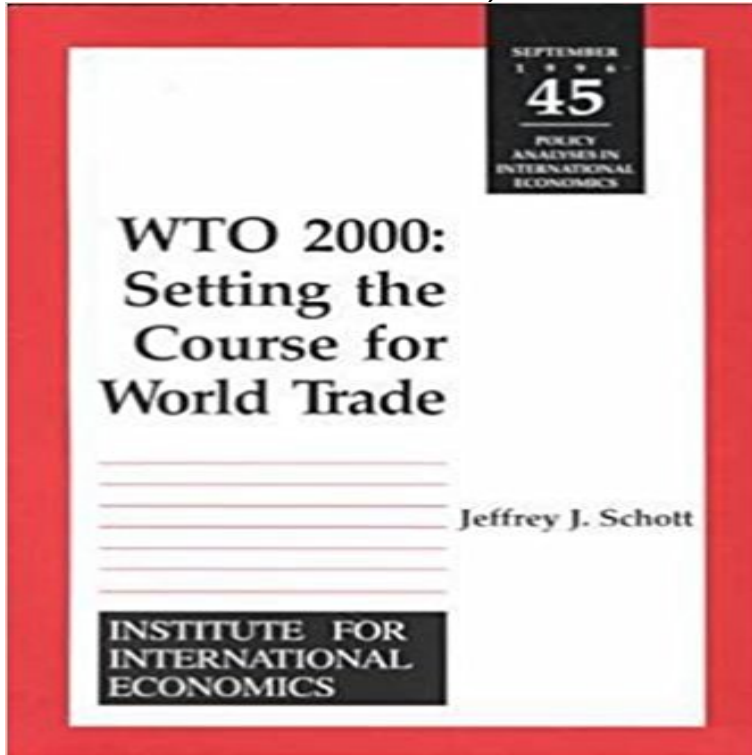


WTO 2000: Setting the Course for World Trade (Policy Analyses in International Economics)



This text discusses the Singapore ministerial meeting and its importance in starting WTO deliberations. It proposes initiatives to achieve further trade reforms and to extend WTO obligations to other trade-related aspects of government policy, whilst exploring whether such initiatives are feasible.
