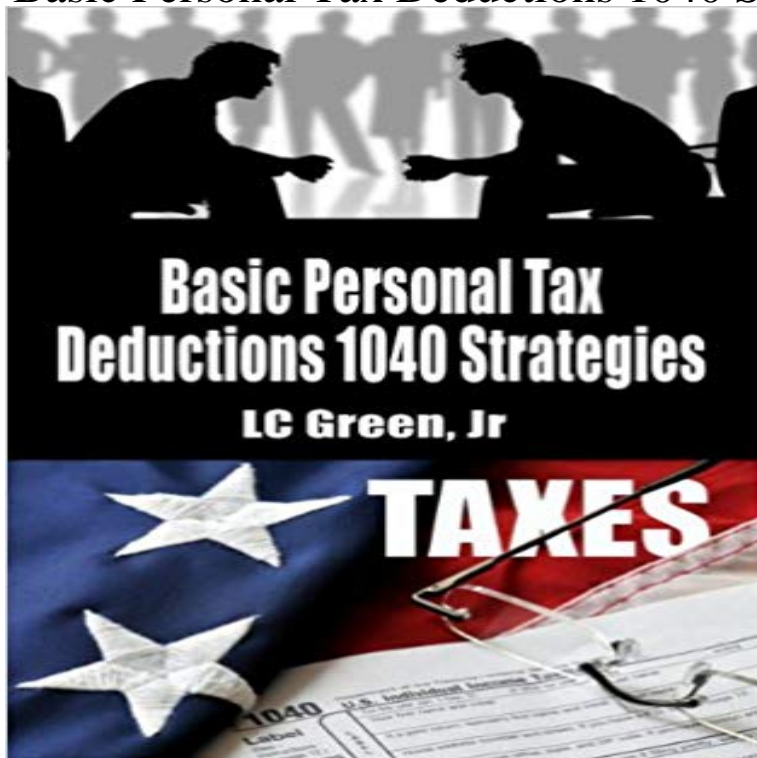


## Basic Personal Tax Deductions 1040 Strategies
