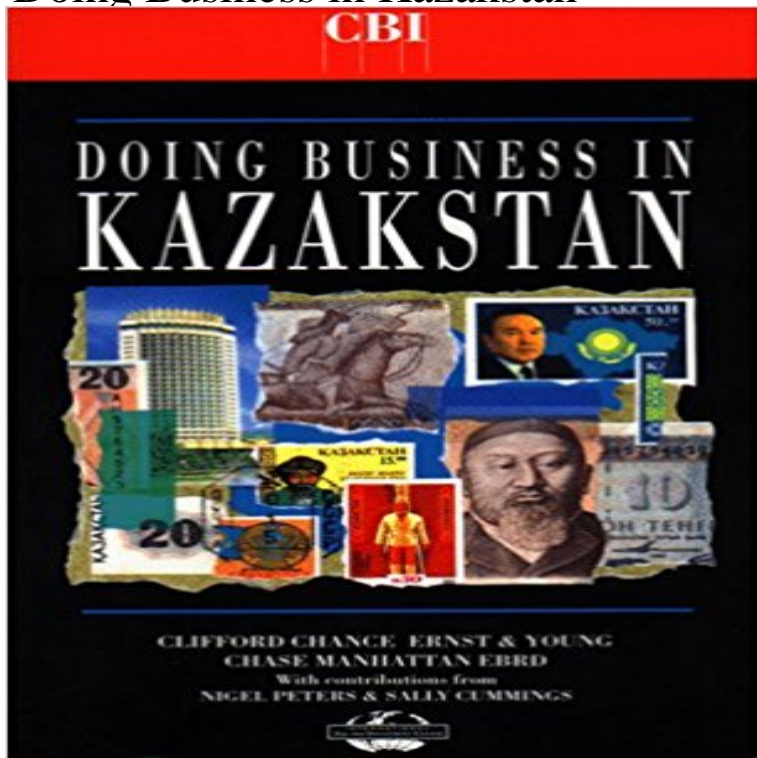


Doing Business in Kazakhstan
