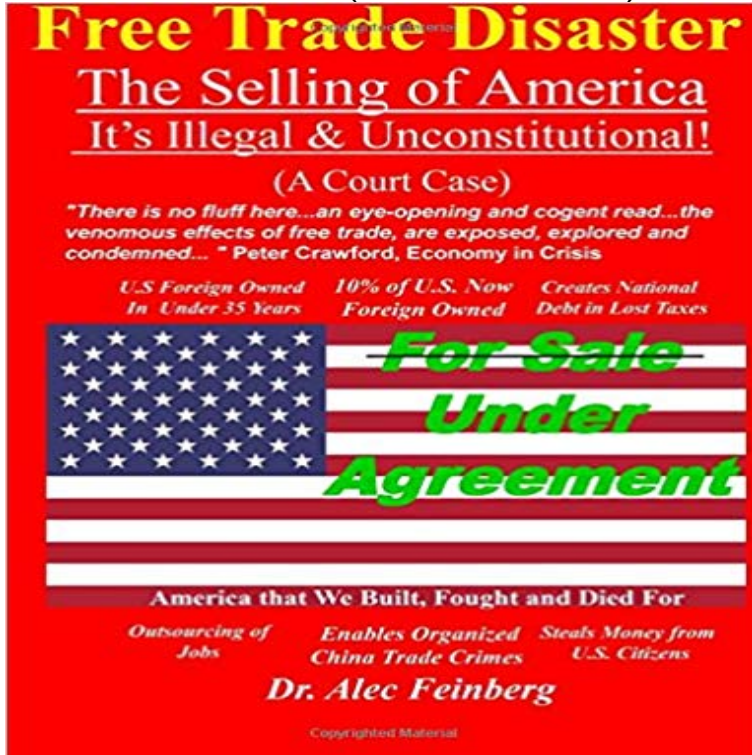


Free Trade Disaster - The Selling of America: Its Illegal & Unconstitutional (A Court Case)
