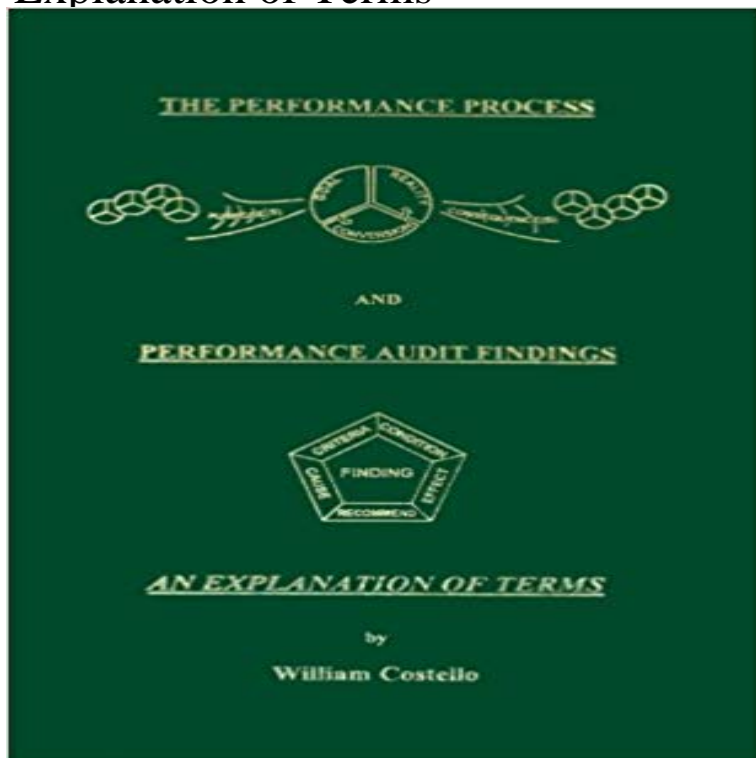


The Performance Process and Performance Audit Findings--An Explanation of Terms
