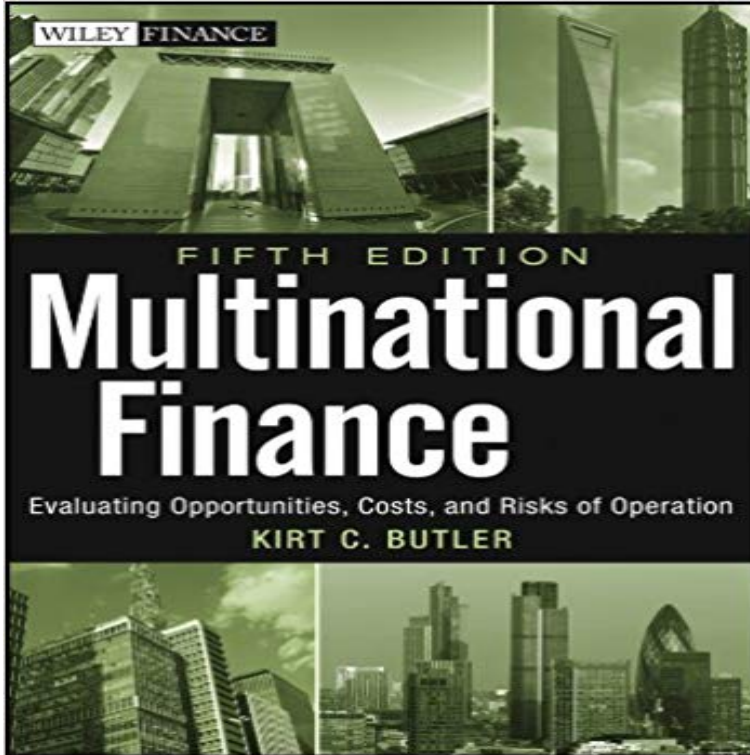


# Multinational Finance: Evaluating Opportunities, Costs, and Risks of Operations (Wiley Finance)
