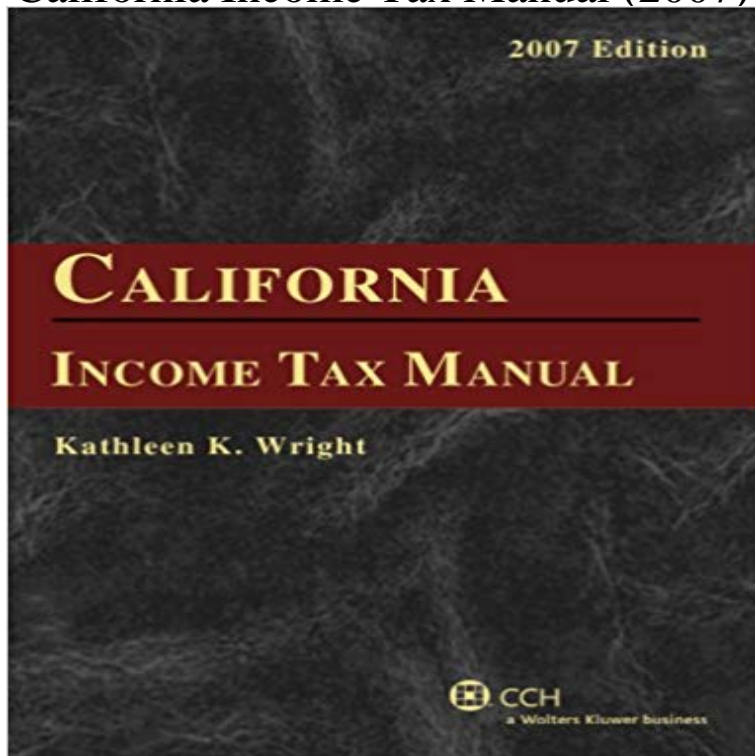


## California Income Tax Manual (2007)
