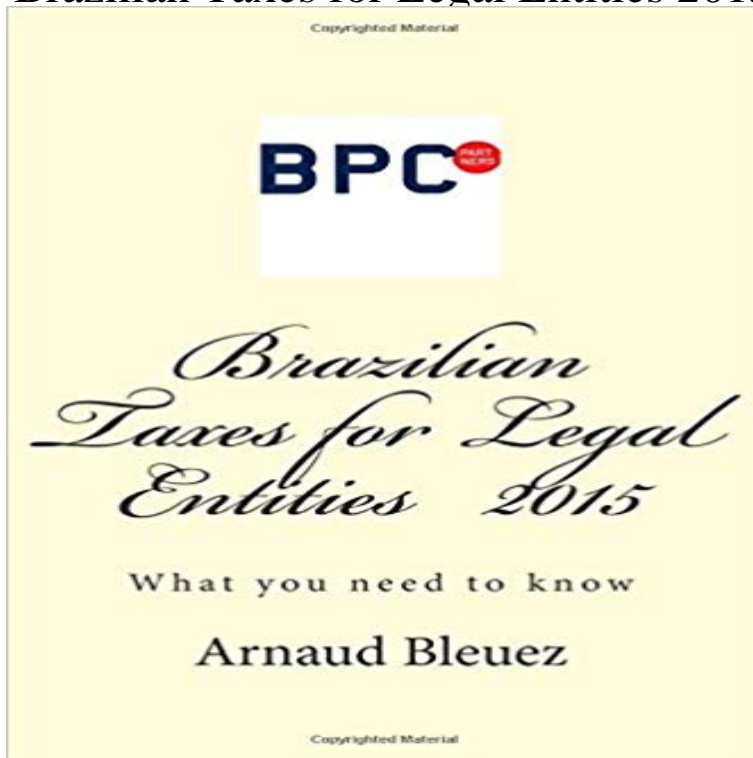


Brazilian Taxes for Legal Entities 2015: What you need to know



In 2015, Brazil was ranked by the IMF at the 120th position (out of a total of 189 countries) on Ease of doing business. The assessment on taxes is even worse: 177th position.
